**Brief information about Associate membership. Extraction from Statute of WCF**

Capoeira groups and any kind of capoeira organizations (Associations, schools, clubs etc) having aims and objects identical to those defined by World Capoeira Federation can request an Associate membership. The President of the Federation adopts the decision on the admission of Associate member. Associate members may participate in WCF's conferences with consultative vote. Associate members cannot nominate their candidates for elections.

Associate members have the following rights:

- to participate in WCF's competitions;
- to bear an official ID document of WCF;
- to send complain to corresponding bodies of WCF regarding admittance to membership and discharge (this item also applies to candidate members);
- to appeal to WCF's Management Board for supporting their interests;
- to object and to complain about corresponding member and body of WCF;
- to be informed about the WCF's activity;
- to participate in discussions related to their own rights and duties.

The obligations of Associate members are:

- to follow the Statute, rules and regulations of WCF, to refer them in the activity;
- regularly participate in WCF's events;
- regularly pay membership fee (your organization will not pay as Associate member. But the individuals who wish to bear a WCF passport should pay individually);
- to assist realization of aims of WCF;
- to implement the decisions of the authorities of WCF.
